WAVIER AND RELEASE AGREEMENT

Please read carefully before signing. This is a release of liability and waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of kennel visits, dogsledding and/or dogcarting; and the use of property and animals, I agree to the following Waiver and Release:

I acknowledge that kennel visits, dogsledding and dogcarting have inherent risks, hazards, and dangers for anyone that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them;
2. The unpredictability of the animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons, or other animals;
3. Certain hazards such as surface and sub-surface conditions;
4. Collision with other animals or objects;
5. The potential of the participant to act in a negligent manner that may contribute to injury to the participant or others, such as sticking legs or arms out of the sled or cart or purposely abusing an animal;
6. Dogsledding or carting in rugged country;
7. Encounters with wildlife, animals, and insects;
8. Temperature extremes;
9. Inclement weather conditions and the unavailability of immediate medical attention in the wilderness in case of injury.

I understand the risks, hazards, and dangers described above and have had the opportunity to discuss them with Mike or Linda Herdering, owners and operators of THE HUSKY DOGSLEDDING EXPERIENCE/Maryland Mountain Kennels, LLC.

I understand that these activities may require reasonable physical conditioning and a degree of mobility to enter and exit the sled or cart. I believe I have that physical conditioning and mobility necessary for me to engage in these activities safely.

I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF MOUNTAIN MARYLAND KENNELS, LLC WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.
